

Alice formerly wife of Richard Horner plaintiff offers herself against Richard de Kerheved in a plea of covenant. Richard does not come and is amerced 3d: order is given to distrain him.

Horbury:- Nicholas del Stockes and his wife, defendants against Joanna Gyge in a plea of trespass, essoin the first time by John de Castilford. Because Joanna offers herself, a day is given.

The suit between **John Malynson** plaintiff and Adam Isbel in a plea of debt in respite.

Stanley:- Likewise between the same in a plea of covenant.

Henry son of Richard de Bateley comes and acknowledges that he unjustly detains from John Couper a stone of wool worth etc., which Henry bought from him. He is to satisfy and is amerced 2d.

Sergeant:- A day is given to Robert de Wyrnthorp plaintiff and William Isbel <puts himself in mercy> and John Carter in a plea of debt.

Hipperholme:- Order is given to distrain Thomas del Dene to answer Richard del Rokes <does not prosecute> who offers himself in a like plea. Likewise Richard de Haselhurst to answer Cecily formerly wife of Roger de Clifton in a like plea.

Sowerby:- A day is given to Isabella de Grenwode <puts herself in mercy > plaintiff and Thomas Culpon in a plea of trespass.

Ossett:- William son of William de Balne gives the lord 2s for heriot on a messuage and 4 acres in Erlesheton after the death of the aforesaid and his mother, whose heir he is.

Sandal:- John son of John Shephird surrenders into the lord's hand 3 acres in Crigleston, which are granted to John Shilvyng to hold to himself and his heirs following the custom of the manor; fine 12d.

Stanley:- Henry son of John Poket gives the lord half a mark for heriot on a messuage and 16 acres in Stanley after the death of his father, whose heir he is.

Horbury:- Margery Garbot surrenders into the lord's hand a cottage and half an acre in Horbiry, which are granted to William Garbot to hold to himself and his heirs etc.; fine 6d.

his wife, alleging that they unjustly deforced the plaintiffs of a <third part> of half a bovate in Alvirthorp <which she claims as her right and inheritance> , of which Robert de Flansowe, brother of Joanna and Matilda, whose heirs they are, was seised; and into which Henry and Christiana have had entry only after Robert leased it to Thomas Torald when he was under age. Henry and Christiana come and say that they hold the land as dower from Adam de Flansowe, once her husband before the said lease. And they seek verification. The plaintiffs say that Adam <once the husband of Christiana> was never seised of the land so that he could endow her, and they present this for verification. Robert, Joanna and Matilda say that Adam was seised of the land so that he could endow her and they present this for verification. An inquiry is to come.

Sergeant:- William de Usflet, parson of the church at Normanton,, plaintiff against Thomas de Birstall <distrain> , for taking a stray, essoins the second time by Richard de Woderove. And because etc. The same Thomas, likewise, by Robert de Grotton, etc. John Tailliour de Normanton, plaintiff against Thomas de Birstall de Normanton <distrain> in a plea of taking beasts, likewise. John offers himself by attorney and a day is given.

William Templer plaintiff offers himself against John de Fery in a plea of land. Because John claims to hold the land by charter, it is to be seized into the lord's hand.

Sowerby:- John de Butterworth plaintiff does not prosecute against John del Rode in a plea of debt. He is amerced 3d.

Hipperholme:- A day is given until the next etc. to William del Bothes plaintiff and Richard del Hole in a plea of land.

Order is given to distrain Richard de Kerheved <again> to answer Alice formerly wife of Richard Horner who offers herself in a plea of \*land\* covenant.

Nicholas del Stockes and his wife, against Joanna Gyge in a plea of trespass, essoin the second time by John de Castilford. Joanna offers herself, therefore etc.

A day is given until the next etc. to **John Malynson plaintiff** and Adam Isbel <puts himself in mercy 2[d]> in a plea of 2 claims.

Alverthorpe:- John le Couper plaintiff offers himself against William Wolf in a plea of debt. William does not come and is amerced 2d; order is given to distrain him. Likewise against Richard Swan <puts himself in mercy> in a like plea. Richard likewise 2d; like order. Likewise against John Garbot in a like plea. John Garbot likewise 2d; like order.

The jury between Robert Shilvyng and Joanna his wife and John Edelot and Matilda his wife, plaintiffs, and Henry Bronsmyth and Christiana his wife in a plea of land in respite for a default of the jury. Order is given to the grave etc.

John Garbot is called to an inquiry and does not come. He is amerced 2d. Richard Swan likewise 2d. William Wolf likewise 2d.

Sergeant:- Order is given to distrain Thomas de Birstall de Normanton to answer William de Usflet, parson of the church at Normanton, in a plea of taking a stray and the lord for default. Likewise to answer John Tailliour de Normanton in a plea of taking beasts and the lord for default.

The suit between William Templer plaintiff and John de Fery in a plea of land in respite, as in the preceding court.

Hipperholme:- William del Bothes seeks against Richard del Hole 6 acres in Hiperum as his right etc. Richard says that he is not bound to answer for his free tenancy in this court because he holds the land by charter displayed by Hugh de Tothill in court, by the gift and concession of Hugh, etc. In accordance with this, a day is given at the next court for summoning Hugh to show how he entered into the land etc.

Order is given again to distrain Richard de Kerheved <puts himself in mercy> to answer Alice formerly wife of Richard Homer in a plea of covenant.

At the request of the parties a day is given to Joanna Gyge plaintiff and Nicholas del Stockes and Juliana his wife in a plea of trespass.

Alverthorpe:- **John Malynson** plaintiff and Adam Isbel agree by licence in a plea of debt. Adam is amerced 2d.

Sergeant:- Order is given again to distrain Richard de Whityngton and Alice his wife to answer Richard de Walton in a like plea.

Sandal:- John son of John le Shephird plaintiff and John son of Hugh

The mill at Rastrick is leased to farm this year to John Milner for £10 10s; pledges, Roger del Hagh, John son of Ellen de Rastrick, Matthew de Tothill, Henry de Tothill, Jankyn de Rastrick, William de Hepworth, Alexander de Wodehous and Adam Shephird.

**Court and tourn held at Burton, Wednesday 13 October 1339**

An inquiry finds that Richard son of Richard Michel beat Henry son of Juliana, damage 6d. He is to satisfy and is amerced 6d. Likewise that **Geoffrey Malynson**, Adam Tailliour and **Adam Malynson** unjustly deforced <Thomas de Hyngclif> of 1½ acres in Thwong. He is to recover seisin; they are amerced 9d.<sup>1</sup>

John Scot unjustly detains 2s from John Tailliour as an inquiry finds and is amerced 2d. Robert del Bothe and Adam del Green come and acknowledge that they unjustly detain 5s from Adam Preest de Birton, <damage 18d> . They are to satisfy and are amerced 4d.<sup>2</sup>

Richard son of Richard is amerced 3d for false claim against Thomas son of Gilbert and others in a plea of trespass.

Adam son of Thomas de Elwardhuls fines 18d to the lord for leave to sell timber of an old house outside the lordship.

Jordan Tailliour and John Elcok de Shepelee unjustly detain 13d from William Elyn. They are amerced 6d.

Order is given to attach William Elyn to answer John Elcokeson, John son of Thomas le Smyth and John son of Alice in a plea of trespass.

Thomas Moldeson surrenders into the lord's hand a cottage and a rood in Cartworth, which are granted to him for the term of his life, with remainder to Margaret his daughter, etc.; she fines 6d. Thomas del Wode likewise a cottage and 1½ acres in Wolvedalemer, which are granted to Henry Leen to hold to himself and his heirs etc.; fine 12d. John son of John de Cartworth likewise a cottage, 12 acres and 3 roods in Cartworth, which are granted to John de Hogley and Alice his wife and the heirs of their bodies. If he dies without such heirs, remainder to the right heirs of John; fine 40d. Agnes daughter of John Robynson

meadow <and half a rood in Osset> by the grant of Thomas Pees for a term of 20 years.

Sandal:- Matilda wife of John Wright fines 6d to the lord for leave to have half an acre of meadow in Sandal by the grant of Thomas de Ketilthorp for a term of 8 years. Roger Shephird surrenders into the lord's hand 3 roods in Criglestone, which are granted to Richard le Quarour to hold to himself and his heirs etc.; fine 6d.

Stanley:- Philip Sagher fines 12d to the lord for leave to have 3 acres of land and meadow in Stanley from Henry Bron for a term of 8 years. **John Malynson and Joanna his wife** surrender into the lord's hand an acre in Stanley, which is granted to Philip le Sagher to hold to himself and his heirs etc.; fine 10d.

Thornes:- **Robert Malyn** likewise half an acre and half a rood in Thornes, which are granted to John de Wolley mazon similarly; fine 6d.

Horbury:- John son of Hugh likewise a messuage and 10 acres of land and meadow in Horbiry, which are granted to John his son similarly; fine 5s.

Holme:- Order is given again to attach William Olyn to answer John Elcokeson, John son of Thomas Smyth and John son of Alice in a plea of trespass.

Rastrick:- A day is given until the next court to Modesta formerly wife of Thomas de Tothill plaintiff and Henry son of John de Rastrick, John Steel, John son of Ellen and Richard del Hole in a plea of debt.

Sum of this court 37s 11d, of which from sergeant 23s 4d, Ossett 22d, Sandal 2s 6d, Alverthorpe 11d, Thornes 20d, Stanley 2s 5d, Horbury 5s 3d.

Richard de Osset is elected grave of Sandal and sworn.
