

Thomas de Meltham gives *6d.* for an inquisition as to whether Gilbert de Alstanley and Adam de Cartewrth were pledges for William le Parmenter for *22s.* on account of cattle sold him. An inquisition finds that they were not.

An inquisition finds that John de Thwong struck Richard de Thwong, and broke the heads of Hugh del Hole and Adam Strekayse. He must pay damages, and *3d.* fine for each offence. It is found that they assaulted him only in self-defence, so he is fined *3d.* for false claim. Pledge, Thomas Ferenhoule.¹

Ellen da. of Maude de Fekesby sues Henry de Fekesby for a tenement in Fekesby, formerly held by Peter de Fekesby as her inheritance ; an inquisition finds that Peter was a bastard, and therefore she has no right in the same. The tenement is taken into the lord's hand till enquiry be made how Henry had entry.

John le Barn, attorney of Thomas his son, v. Henry s. of Thomas, for impounding his sheep. Deft, says he is a freeman, and not obliged to answer in this Court. He is to come to the next Court at Wakefield.

A quarter of a bovate of land, left on the Earl's hands by Celia [*sic*] da. of Richard de Thothill, is granted to Richard de Thothill till the said Cecilia [*sic*] comes ; if she does not come, to hold to him and his heirs. Fine for entry 6*d.* Pledge, Adam the Grave.

An inquisition, finds that Matthew de Thohill [*sic*] harnessed to a plough a heifer [*juvenca*] which he took from Malina de Fekesby for first issue [*pro prime exitu*], viz. milk and calf; she is to have the heifer back again, as he used her for labour, and he is fined 6*d.*
